



More Power to You CO-OP MEMBER GRATEFUL FOR DONATIONS TO PROJECT LIFT UP

We don't often get to hear the stories about people who have benefitted from our charitable donations, but Mary Dalton wants to share her story and thank the wonderful people who contribute to Project Lift Up.

Just as the name implies, Project Lift Up gives people a financial lift when they need it most. Rock Energy members can donate to the program by rounding up

their monthly energy bill to the nearest dollar, adding a set monthly contribution, or making a one-time donation. Most contributions come in the form of pennies, nickels, dimes, and quarters. Considered separately, that spare change might seem in-

significant. But when combined, that small amount of money could help your neighbor in a big way.

Co-op members have donated almost \$20,000 since the program started in 2009. These gifts help fund Rock Cooperative Care, our program that assists co-op members with their energy bills. About \$202,000 has been awarded to members who might otherwise fall through the cracks because their

incomes are too high to qualify for federal assistance but too low to make ends make.

For the past three years, Mary hasn't worked much because she's had several foot surgeries, including one that caused a bone infection and required the removal of the heel on one foot. During this time, she had always managed to pay her monthly bills—until this past summer. That's when she received a grant of about \$220 from Rock Cooperative Care.

"I was grateful for whatever help I could get," she says. "It's a great program and made it so I didn't get behind on my bills."

Mary is telling her story because she wants co-op members to know that people who receive assistance aren't looking for a handout. Oftentimes, they just are falling on hard times

and need a boost to get them back on track.

Each day she thinks about the people who have been so kind to her and helped her along the way. "Anyone who donates, I think they are the most wonderful people," she says. "They are a blessing—a big blessing."

Mary is also quick to help others when her health permits, volunteering at the Caritas Food Pantry in Beloit. People

ROCK COOPERATIVE CARE OFFERS ENERGY ASSISTANCE

Some Rock Energy Cooperative members need a little help paying their energy bills. They might earn too much to qualify for state and federal energy assistance, or they might need some extra money to supplement the other programs.

Either way, Rock Cooperative Care is available to help. Since 2010, more than \$202,000 has been distributed to help members.

A one-time grant of up to \$500 is available to help residential members who are struggling to pay their energy bills but do not meet more stringent state and federal requirements.

Check the following chart to see if your household qualifies for assistance. For example, a four-person household would be eligible if the total annual income is \$73,800 or less.

The Salvation Army office administers the Rock Cooperative Care program. If you meet the eligibility requirements, call either of these offices during regular business hours to schedule an appointment: Janesville, (608) 757-8300, extension 26. or Rockford,



(815) 972-1135. Be sure to point out that you would like to schedule an appointment to apply for the Rock Cooperative Care program.

HELP ALSO AVAILABLE THROUGH STATE, FEDERAL PROGRAMS

The Wisconsin Home Energy Assistance Program (WHEAP) also helps eligible low-income households pay for winter energy services.

The program's heat and electric assistance is a one-time benefit payment per heating season. The amount depends on household size, income, and energy costs.

You are eligible for heating assistance through WHEAP if your household's combined income is at or below the levels shown on the accompanying chart.

Since 1989, Rock Energy has awarded more than \$97,000 in financial aid to deserving students.



In addition, scholarships of \$2,000 will be awarded through the Thomas H. Moore Illinois Electric Cooperatives (IEC)

Memorial Scholarship Program. These scholarships are available to high school seniors who are the sons or daughters of an Illinois electric cooperative member receiving service from the co-op. Applications must be completed online at www. rock.coop. Just go to the Community & Youth tab and click on Scholarships. The deadline is Dec. 31.

RATES WILL CHANGE JAN. 1

Effective Jan. 1, 2018, the monthly facilities charge on most electric accounts will increase \$1. This adjustment moves the monthly charge slightly closer to the actual fixed cost of serving an account and will allow the per kilowatt-hour energy charge to remain relatively steady in 2018.
