Most drivers are unaware of the clear and present danger of downed lines, and so, the "License to Live" campaign was born. You are important to us. Your safety is precious. We want you to know exactly what to do if your car comes into contact with a utility pole or wire.

WHAT SHOULD YOU DO?

- STAY IN YOUR VEHICLE and call 911.
- ONLY GET OUT of the vehicle if it is on fire.
- IF YOU MUST get out, jump from the vehicle with both feet together, and shuffle your feet on the ground as you move away from the scene.
- ALWAYS ASSUME all wires and equipment are electrified.

ENERGY EFFICIENCY TIP OF THE MONTH



Unplug electronics, or use a power strip and use the switch on the power strip to cut all power to the appliance, to avoid "vampire" loads. Many appliances continue to draw a small amount of power when they are switched off. These vampire loads occur in most appliances that use electricity, such as DVD players, TVs, stereos, computers, and kitchen appliances. Unplug battery chargers when the batteries are fully charged or the chargers are not in use.
