### **Financial Stability**

The cooperative is in solid financial condition. All obligations in 2024 were satisfied, and we expect another positive year in 2025. We encourage you to review the financial statement on page 17.

As a member of the cooperative, you participate financially in the form of capital credits. That money is used as working capital to operate, maintain, and upgrade the co-op's energy distribution system. When the co-op's financial situation allows, some of that capital is returned. In 2024, Rock Energy distributed more than \$1.2 million to current and past members. Since the co-op was founded 89 years ago, more than \$27 million has been paid back.

Your economic participation in Rock Energy is one of the many qualities that make energy co-ops different from other types of utilities. While profits are very important, they do not drive us as a not-for-profit cooperative. We exist for the mutual benefit of our members, and those benefits include capital credits. We don't need to make profits for out-of-town investors. We exist solely for our members.

#### **Continued Improvement**

The co-op also continues to maintain and improve its electric and natural gas distribution infrastructure. These enhancements not only provide you with needed energy, but they also help officials attract new business and industry to our communities.

## **88th Annual Meeting Minutes**

### Rock Energy Cooperative 88th Annual Meeting – April 8, 2024

Chairman Clark Schoonover welcomed all in attendance at the 88th annual meeting of Rock Energy Cooperative on Monday, April 8, 2024, at the Eclipse Center in Beloit, WI. He called the meeting to order at 5:30 p.m. A quorum was declared with 150 voting members in attendance. Introductions of the board of directors, CEO, and attorney were made.

The reading of the notice of the meeting was waived by unanimous consent. The minutes of the previous annual meeting were approved as printed. The year-end financial reports were printed in the March magazines for review by members. A motion was made, seconded, and carried to approve the reports as presented.

Chairman Schoonover and CEO Larson addressed the 399 attendees at the Very Special Solar Eclipse evening. It was the first sit-down full meal catered by the Hoffman House since COVID changed our annual meetings. CEO Larson recalled the annual meeting in 2006 held at the Holiday Inn Express in Janesville that welcomed 850 attendees. Many changes have taken place since then.

Great employees and directors with vision have kept Rock Energy financially strong and growing. Our weather has had 20% lower heating degree days resulting in 9% less therms of natural gas usage. Electric and natural gas costs have gone up significantly. Demand costs went up 54% in the last three years. \$8.4 million has been invested in the plant.

Inflation also affected our costs. Big issues included an ice storm and the first ever tornado in February 2024. Slides of the damage were shown. Drone photos were valuable for linemen to view the area in order to assess the needs to make necessary repairs.

Attorney Niles Berman conducted the election of directors. The reading of the nominating committee minutes was waived by unanimous consent. The minutes were approved as printed in the magazines. The candidates were District 1: Barb Miller, incumbent, District 3: Theresa Huber, incumbent, and District 5: Bill Fischer, incumbent. Since all the candidates were uncontested, pursuant to the Bylaws, a voice vote was taken. All three were elected unanimously.

There was no unfinished business.

One question from the membership was addressed as new business. A few other questions were given to staff for personal phone answers to the members following the annual meeting.

Drawings resulted in two members receiving an \$88 credit toward their monthly energy bill.

Attorney Niles Berman was presented with a plaque honoring his service to Rock Energy Cooperative as our attorney since 2013 following the death of long-time attorney, David Collins. Niles was a strong advocate for Wisconsin electric cooperatives for 49 years. His knowledge and presence will be greatly missed.

The business meeting adjourned at 5:58 p.m.
