## Report from the Chairman of the Board and Chief Executive Officer

This year, once again, Rock Energy Cooperative will be holding its annual meeting as a “Business Meeting” only. In 2020 our annual meeting was moved from March to September as the pandemic hit and forced everyone to adjust. Last year, the board again decided to hold the Annual Meeting without a dinner or other activities, which is what we will be doing again this year at our Annual Meeting on Sept. 19, 2022. Even though there will not be a dinner, a scholarship presentation, or kids’ activities, the event will proceed as an in-person meeting (business only), and we hope to see you there.

### FINANCIALLY SOUND AMIDST CHALLENGING TIMES

Looking ahead, Rock Energy cautions that although the co-op’s financial outlook for 2022 is good, the markets have changed since the early months of the year. In addition, there has been a drive to reduce carbon emissions leading to a rapid pace of coal plant retirements. This coal has been largely replaced with natural gas, which is subject to volatile price swings.

Natural gas prices surged over 100% in 2022 and over 200% since January 2021, which, unfortunately, has caused gas prices and utility bills to go up substantially. There were several factors contributing to the increase, including extreme temperature swings, both in the winter and summer. Natural gas inventories (natural gas put into storage) are below past year averages—this factor drives supply concerns.

### THE COOPERATIVE ADVANTAGE

Despite the rising gas prices and the havoc it’s caused, financially, Rock Energy is well prepared for the future. For instance, we returned \$1.2M in capital credits back to current members in 2022, and \$200,000 back to past members. Capital credits represent member equity in the cooperative. As the cooperative is financially able, it is a privilege to return a portion of your investment in the cooperative back to you.

## SAFETY & RELIABILITY

In order to continue to provide reliable service, Rock Energy dedicates a significant amount of resources for tree trimming and line maintenance. Tree trimmers traverse our 1,200 miles of line to remove tree branches and other vegetation growing too close to power lines in the right-of-ways.



While most everyone can agree that trees are beautiful and are an important part of our landscape — safety and reliability are our main priorities. Trees can become dangerous if the branches grow too close to power lines and become energized. Trees also can be a power line's worst enemy. Strong winds, heavy snow and ice can cause trees and their branches to snap, pulling down power lines and causing outages.

Line maintenance involves more than just tree trimming, as we continually inspect poles and lines every year. If certain issues are discovered, repairs are made.

Working to minimize and prevent outages is an on-going effort, as we maintain proper engineering and inventory of parts and train our employees throughout the year.

## ROCK ENERGY SCHOLARSHIPS

Earlier this year, Rock Energy once again awarded 15 scholarships to local high school students. Each student will receive \$1,000 totaling \$15,000. Students whose parents or guardians are members of Rock Energy were eligible to apply. Funds for the scholarships come from unclaimed capital credits. Since 1989, the co-op has awarded more than \$152,000 in financial aid to deserving students. These young scholars possess the qualities that will help them succeed in their college studies, as well as their future professions, and Rock Energy is proud to support them on their journey forward.

## YOUTH LEADERSHIP CONGRESS & D.C. YOUTH TOUR

Rock Energy, as in years past, offered additional opportunities for our member youths in 2022, including the opportunity to attend the Youth Leadership Congress summer event and the Youth Tour in Washington, D.C. The annual WECA Youth Leadership Congress (YLC) took place this year at a new destination — the University of Wisconsin-Stout, in Menominee, WI. Rock Energy is happy to report that five of our members attend this year. YLC is a dynamic three-day event sponsored by Wisconsin's electric cooperatives and facilitated by WECA. It is a unique opportunity for youth to develop their leadership and communication skills, while learning the purpose, operation, and scope of cooperative businesses. The program focuses heavily on understanding not just cooperatives, but on co-op governance as well. For example, one of the main activities at the event involves students setting up, organizing and operating a functioning cooperative. On the Youth Tour, teens can travel to Washington, D.C. to explore monuments and museums, and meet with members of Congress. Attendees discover leadership lessons from our nation's history, while they are immersed in the cooperative spirit that built our nation.

## 85th ANNUAL MEETING MINUTES

### Rock Energy Cooperative 85th Annual Meeting – September 27, 2021

Chairman Clark Schoonover welcomed all in attendance at the 85th annual meeting of Rock Energy Cooperative on Monday, September 27, 2021, at the Eclipse Center in Beloit, WI. He called the meeting to order at 6 p.m. A quorum was declared with 24 voting members in attendance. Introductions of the directors, CEO, and attorney were made.

The reading of the notice of the meeting was waived by unanimous consent. The minutes of the previous annual meeting were approved as corrected to include the order to destroy the ballots from the election at the previous year's annual meeting. The year-end financial reports were printed in the September magazines and placed on their seats for review by those present.

Chairman Schoonover and CEO Larson reported an 85° temperature outside for REC's 85th annual meeting. COVID is still causing a shortened meeting. Larson stated, "The more things change, the more they stay the same." Change is definitely the name of the game. In February 2021, the challenge was a massive increase in natural gas prices due to a deep freeze in the southern United States. While the energy sector is experiencing significant changes, just like the past 85 years, we will continue our commitment to provide reliable service to our members.

Attorney Niles Berman conducted the election. The reading of the nominating committee minutes was waived and by unanimous consent those minutes were approved as printed in the magazine. The candidates were District 1: Barbara Miller, District 3: Theresa Huber, and District 5: William Fischer. Since all the candidates were uncontested, pursuant to the Bylaws a voice vote was taken. All three were elected unanimously. Niles congratulated Darrel Weber on his retirement after serving 30 years on the board of directors.

Action was taken on the 2021 proposed change to the REC Bylaws Article II, Section 1. This year, an emergency bylaw, adopted by the board pursuant to recent legislation, allowed the annual meeting to be held later in the year than usual. The proposed change would allow more flexibility in scheduling the annual meeting without need for an emergency bylaw:

Membership Meetings Section 1. Annual Meeting: An Annual Meeting of the members of the Cooperative shall be held at such time as determined by the Board of Directors, within **six twelve months** after the close of the fiscal year.

A motion was made, seconded, and carried unanimously, to approve the Bylaw change.

There was no unfinished business.

New business – Darrel and Patsy Weber were invited on stage to be honored for their dedicated service to the co-op. Darrel was presented a plaque recognizing his 30 years (1991-2021) serving as the Rock Energy Cooperative director representing District 3. He was active in many roles through the years having served as Chairman and Vice Chairman of the board.

Two door prize drawings were awarded. The member winners received an \$85 credit on their Rock Energy bill in honor of the 85th annual meeting.

The meeting adjourned at 6:20 p.m.
